Go to irs.gov/directpay Click "Make a Payment" Select reason for payment (Balance Due, Estimated Tax, Extension) Select tax form (1040, 1040-ES, etc.) and tax year Enter SSN, date of birth, name, and address exactly as on tax return Select prior year for verification and enter filing status Enter bank routing number and account number Select checking or savings Choose payment date (today or up to 365 days ahead)

EFTPS Enrollment Checklist (Businesses)

Required for payroll tax deposits. Allow 5-7 business days for PIN:

- □ Go to eftps.gov
- □ Click "Enrollment" then select "Business"
- □ Enter EIN exactly as registered with IRS
- ☐ Enter business name and address (must match IRS records exactly)
- ☐ Enter bank routing and account numbers
- □ Submit enrollment
- □ Wait for PIN letter by mail (5-7 business days)
- □ Call 1-800-982-3526 to get temporary Internet password
- □ Log in with EIN, PIN, and temporary password
- □ Create permanent password

NOTE: As of October 17, 2025, new individual taxpayers cannot enroll in EFTPS. Use IRS Online Account or Direct Pay instead.

Date	What Happens	
Sept 30, 2025	Paper refund checks phased out for most taxpayers	
Oct 17, 2025	EFTPS closes to new individual enrollments	
Jan 2026	2026 filing season begins (for 2025 returns)	
April 15, 2026	2025 tax returns due (must include direct deposit info or request exception)	
~2027	Electronic payments to IRS likely required (exact date TBD)	

Troubleshooting Common Issues

Problem	Solution	
ID verification fails	Try better lighting; use video call option instead	
Can't verify identity online	Visit IRS Taxpayer Assistance Center in person	
Name doesn't match	Enter name exactly as shown on tax return	
Payment not showing in account	Wait 2-3 business days; check bank statement	
Forgot confirmation number	Check email if you opted for confirmation; check bank statement
